Exciting New Projects at EMC and E-Konnnect!

- EMC was appointed by HDFC Ltd. to conduct an Environmental and Social Due Diligence of three projects in which they are planning to invest. The assessment included assessment of measures undertaken on environment, health and safety management at the project site including safe work practices, waste management, training of workers, incident management, emergency preparedness & response, and community grievance redressal.
- EMC is conducting dispersion modelling study using AERMOD to model the impact of Tata Powers Trombay plant on the urban air quality in Mumbai.
- EMC is conducting ESDD of a blockchain based traceability platform that enhances supply chain visibility for Agri Impact Fund.

Some Project Updates

- Ekonnnect Knowledge Foundation was appointed by Godrej Properties to conduct Impact Assessment of their Watershed Development Project implemented in 3 villages of Beed district as a part of Corporate Social Responsibility. A local NGO was appointed by Godrej to set up structures like loose boulder structures, stone gully plug, continuous contour trench, water absorption trench, farms bunds etc. as a part of watershed management interventions. Ekonnnect conducted Watershed Impact Assessment and Socioeconomic Impact Assessment to study the impact of these intervention on the watershed and livelihoods of people in these villages.
- EMC was engaged by Aga Khan Agency for Habitat to develop a comprehensive Climate Change Risk Assessment Framework for the urban settlements. The framework focuses on addressing risk to urban habitat from different natural and climate change induced hazards. Such a framework can help the City administrators, City planners and architects, to plan and prepare short-term mitigation and long-term adaptation strategies. This framework was then applied to Ahmedabad City to assess the climate risk Ahmedabad City is facing. AKAH along with EMC organized a workshop to share the Framework and its application to Ahmedabad City with the stakeholders. Various stakeholders including NGO, Developmental Organization, Educational Institute, Municipal Corporation, Gujarat Climate Change Cell, etc. were invited to the workshop.

EMC on Stewardship council of Inclusive Capitalism

Top 3 winners of the WasteEntrepreneurs Announced

Ekonnnect Knowledge Foundation, with support from HT Parekh Foundation, announced the WasteEntrepreneurs program in October 2021 to support entrepreneurs working towards promoting Circular Economy. Applications were invited from start-up enterprises with a Minimum Viable Product (MVP) or established Proof of Value (PoV) working towards promoting Circular Economy in the Construction, Textiles and Packaging Sectors.

Ekonnnect received submissions from 53 enterprises. Thirty enterprises were shortlisted who received several rounds of mentoring. After virtual pitching sessions in front of a panel of Jury, top 6 enterprises were selected for further due diligence.

Finally, 3 enterprises have now been shortlisted as the winners of WasteEntrepreneurs program. These are Saltech Design Labs Private Limited (Construction theme), InfinityBox (Packaging theme), and reCharkha - The EcoSocial Tribe (Textile theme). These winners will be awarded with a grant of INR 5 Lacs each to further and strengthen their operations.
